### **VENDOR BOOTHS**

- Violation of rules will result in removal from event Merchandise / Exhibitor Booth and all fees withheld.
- **Vendor is responsible for and must provide its own:**
  - 1) Canopy
  - 2) Tables
  - 3) Chairs
  - 4) City of Chino Business license (a one-day license is available - see application)

### **VENDOR MOVE-IN**

1. The vendor must be at the show ground by 7:00 am. A written request must be submitted if requesting a later time.
2. Entrance is located at the back entrance of St. Margaret Mary School located at Telephone Avenue. Please follow staff direction
3. Vendor spaces must be occupied by 8am and a vendor staff must always be present at booth.
4. Vendor vehicles must be removed from car show area and parked in south lot (located at main entrance) by 7:15 am. (Please follow staff direction.)
5. Vendor must have permits on hand.

### **CONDUCT**

1. All instructions by event staff must always be respected.
2. We request that all vendors conduct themselves in a reasonable and professional manner.
3. If for any reason you have questions, comments, or concerns about the event, its rules, or its staff you are always welcome to contact the event management, located at the information booth, during the event.
